Roll was called, and a quorum was verified. The meeting was called to order by Chairman Solo Wainio

- Approval of the agenda at the Discretion of the Chair.
- Approval of minutes of Julyl 24, 2023 moved by Glen, seconded by Nicholas. Approval of the minutes of August 28, 2023 moved by Glen, seconded by Jim Logan.
- Public comment: Glen Wildenburg sent a letter concerning zoning changes for the proposed subdivision on County K, between Hoskins road and Rita Lane, which has been reviewed by the PC members. Dick Logan Mentioned ARDC Senior nutrition program being trialed in early October.
 Town Board Liaison Report: John Grimmer discussed several items. North Lakeland Elementary was named a Blue Ribbon School, quite an honor. Joe Discianno will be working with the County on LRIP grant status. It was mentioned that 911 addresses need to be updated. Another meeting is scheduled October 3 at 6pm concerning changes in the Northwoods EMS organization between Winchester, Presque Isle, Manitowish Waters and Boulder Junction. Overweight trash compacters have been noted on county roads, a safety and DOT issue. This will be discussed with the transfer station attendant.
